Instructions for Authors

Submission of manuscripts

South European Society and Politics is a refereed journal. Articles submitted should be original contributions and not under consideration for any other publication at the same time. Exceptions to this rule should be clearly indicated at the time of submission.

Articles should be 7,500–9,000 words in length, including endnotes and references; the length of other contributions will be set by arrangement with the Editors. The text may be accompanied by a maximum of six diagrams (tables, figures, graphs, maps, etc.) Articles should be submitted to the Editors via email, preferably in Word. Authors should provide brief biographical detail including affiliation, status, recent publications and current mailing address. The article should begin with an abstract of 100 words describing in general terms its contents and conclusions, followed by up to six keywords. Figures, graphs and tables must be of adequate quality for reproduction; if possible they should be provided as separate files in excel .tif or .eps formats. Photos should be high-contrast black-and-white glossy prints. All tables and figures should be referenced in the text and suitable captions should be provided. Articles should include a maximum number of 12 endnotes (not footnotes) and must conform to journal style. We regret that submissions which do not meet the above requirements cannot be accepted.

Spelling: British punctuation and spelling should be used throughout. Dates should be in the form 5 September 1990; 1994–98; the 1990s. There should be minimal use of capital letters and full points (e.g., UK rather than U.K., government rather than Government).

Subheadings: main subheadings should be emboldened, ranged left above the section, with initial capitals on main words; second level headings should be italicized, ranged left, with initial capitals for main words. Third level headings should be italicized, ranged left, with sentence initial capitalization only and the text following on after a full point.

Quotations: these should be in single quotation marks, double within single. Quotations of 40 words or more should be indented without quotes.

Notes and references

Notes should be gathered together at the end of the article, and should be numbered consecutively throughout the article. Bibliographical details for all cited works must be given in a ‘References’ section at the end of the article, which should adhere to the conventions of the Harvard referencing system, as shown in the examples below. Foreign language sources should be given in the language of publication, with the name(s) of the author(s) given in a Latin form. Where Greek characters are used, an English translation should be given in square brackets.
